- **Two** copies of all entries are required and should be mailed to Literary Awards, Henry Lawson Society of NSW Inc, PO Box 235, Gulgong 2852.
- A completed entry form and entry fee must accompany each entry. Additional entries may be listed on an attached sheet of paper.
- Personal details ***MUST NOT*** appear on the entry. Entries not adhering to this rule will be disqualified and entry fee forfeit.
- All entries ***MUST BE*** the original work of the individual entrant.
- All entries must be a work of fiction. An open theme applies.
- Entries must not exceed 1,000 words, word count must be given opposite where indicated.
- Entries must not have previously placed 1st in any competition, as at closing date of entries.
- Entries under consideration in other competitions are acceptable.
- Entries should be typed on one side of white A4 paper, double spaced, with generous margins. No decoration on cover sheet and/or entry is to be included.
- Please include title and page number on each page.
- Entry forms may be photocopied. Additional entries may be listed on reverse of entry form.
- Entries forwarded by electronic means are not accepted.
- All entries are to be available for reproduction and /or publication by the Henry Lawson Society of NSW Inc. Copyright will be retained by the author.
- The judge's decision will be final and no correspondence will be entered into.
- Please include business size SSAE (DL size, 22 x 11cm only) if copy of results and judge's general comments are required. Due to the number of entries received individual comments are not possible.
- Major prize winners will be contacted prior to the Henry Lawson Heritage Festival. Winners are encouraged to attend the Literary Awards Dinner and receive their awards.
